The year 2919-2020 was very disturbing due to COVID19 pandemic around the globe. There were lockdown in Pakistan as in rest of the world which restricted peoples movements and thousands of people suffered in terms of job loss, business losses, food shortages, health issues and also loss of education of children.

PVDP in this grave situation during the COVID19 took optimum precautions and assured safety and security of its staff in head office Mirpurkhas as well in regional office Islamkot Tharparkar.

Taking all protective measures during the pandemic, PVDP kept contacts with the project communities in Mirpurkhas and Islamkot and tried its best to help the affected communities with relief goods, awareness sessions and protective measures through

wearing of face masks, use of sanitisers and wearing of hand gloves.

Emergency project was initiated through DKH (Diakonie Katastrophenhilfe) in Tharparkar to respond to COVID19 under which 2500 very poor and marginalised communities were supported with food packages, awareness and protective supplies as well as seed was provided for kitchen gardening. Beside this latrine support as well as solar powered water pumps were provided to community and health and hygiene sessions were conducted.

In Mirpurkhas district Pakistan Partners Initiatives (PPI) supported PVDP in training youth in various employable skills such as tailoring, motorbike repairing, mobile repairing, business enterprise and beautification skills. Beside this In COVID19 context cash grant was provided to 50 vulnerable families as well as dry ration was provided to 75 most poor households.

PVDP is grateful to DKH and PPI for the very much needed support to communities during the challenging period of COVID19. As the pandemic is still continuing PVDP is taking all possible measures to secure its communities as well as staff working in PVDP.

About PVDP

Participatory Village Development Programme (PVDP) started its development journey from District Tharparkar in 1997. Mr. Dominic Stephen, founder of PVDP, realized the gravity of the situation and the complex socio-psycho and economic problems of Thari communities and established PVDP in 1997. PVDP was registered on 15 th June 1998 under the Societies Registration Act I860 in Hyderabad. The organization was formed with a mission to support the poor and disadvantaged communities in improving the qualities of their lives, through encouraging people to organize and mobilize themselves for holistic social change.

PVDP is working in the most challenging, poverty and disaster stricken districts of Sindh Province to support most vulnerable people. From 1997, PVDP is engaged in drought mitigation programme in District Tharparkar and supported thousands of families to make them drought resilient. In year 2010, PVDP started work outside of District Tharparkar for the flood affected communities in severely affected districts of Sindh Province; Khairpur, Thatta, Umerkot, Mirpurkhas, Badin and Sanghar. PVDP focuses on poverty reduction, drought mitigation, primary healthcare, primary education, community empowerment, disaster risk reduction and disaster emergency response.

The progress Report 2019-20

Drought Response Project

In Drought 2018-2019, Participatory Village Development Programme (PVDP) with the financial assistance from DKH (DiakonieKatastrophenhilfe) has implemented a 6 months drought response project in Union Council (UC) Vejhiarof Taluka Mithi DistrictTharparkar. Under this project, PVDP has reached a total (a total 2135households.

Through said project PVDP provided multiple assistance to drought affected families i.e. livestock feed and fodder, conducted 75 livestock& 75 crop management session with targeted community to enhance their knowledge on advanced techniques on livestock management, distributed seed to 500 farmers, Beside this, PVDP also trained 16 community members as a Community Animal Health Workers (CAHWs). To support the most vulnerable families PVDP provided multipurpose cash assistance to 155 most vulnerable families.

Project Title: Provision of humanitarian relief to drought affected communities in UC Vejhiar, District Tharparkar, Sindh Province.

Project Duration: 15th May 2019 to 14th November 2019 (Six months)

Drought Response Project

In Drought and COVID-19 during 2020, Participatory Village Development Programme (PVDP) with the financial assistance from DKH (DiakonieKatastrophenhilfe) is implementing 10 months drought and COVID-19 response project in Union Council (UC) Vejhiar of Taluka Mithi District Tharparkar. Under this project, PVDP has reached a total 2780 households.

Through said project PVDP provided multiple assistance to drought and COVID-19 affected families i.e. provision of food packages to 2500 COVID-19 and drought vulnerable families in District Tharparkar, provision of latrine material including one WC, one drainage, 3 cements bags to 800 vulnerable households, installation of 10 solar powered submersible water pumps in deserving villages, conducted 60 health and hygiene sessions with men, women and school children in all 20 villages of Union Council Vejhiar, 20 CLTS sessions and 20 refreshers have been conducted with 20 communities from the targeted UC, 40 Kitchen Gardening management sessions have been conducted with 1000 women and the seed for installation of Kitchen Gardening have been also provided.

Project Title: To reduce impact of COVID-19 & drought by providing integrated humanitarian assistance to targeted communities by end of project. .

Project Duration: 1th May 2020 to 28th February 2021 (Ten months)

Project Area: Union Council Vejhiar Taluka Mithi District Tharparkar (Food Packages are distributed in throughout district)

Specific Objective 1: To ensure survival of COVID -19 affected communities by providing food packages and protective equipment to 01 affected UC of district Tharparkar.

Result 1: 2500 HHs supported with Food packages, awareness and safety material in response to COVID-19

Result 2: 1000 HHs has received vegetable seeds and sessions for kitchen gardening by end of project.

Specific Objective 2: To establish WASH facilities and improve hygiene practices in 01 drought affected UC of district Tharparkar.

Result 1: 10 solar submersible water pumps have been installed in the targeted and deserving communities.

Result 2: 800 HHs will receive latrine material and hygiene sessions by end of project

Management

PVDP Management met to review project work in Islamkot, Tharparkar and Mirpurkhas districts particularly in the context of COVID19 context and took measures to provide protection against the pandemic to its staff, community and other stakeholders.

Meeting with stakeholders including government departments at district levels continued during the year and best coordination was maintained to provide maximum support to the project communities as the staff.

Governance

The Board of Governance of PVDP met twice a year to review the overall functioning of the organization. It was pointed out during the Board reviews that PVDP need to prepare its next Strategic Plan of three years after its current strategic plan ends in 2018. Beside this also it was emphasized that PVDP needed to update its organizational policies
